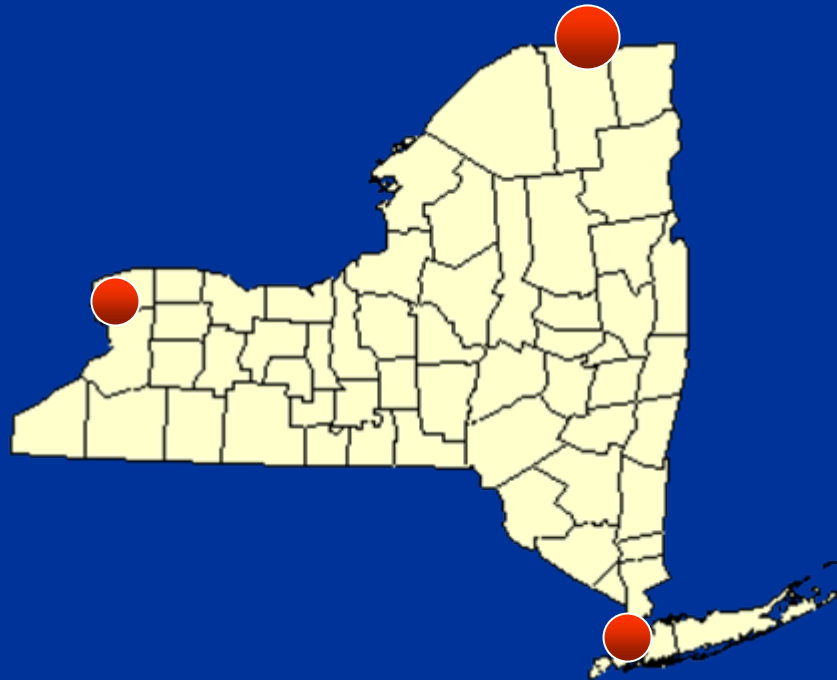




# What types of goods are imported?

- Banned in U.S.
- Causes allergic reactions, rash similar to nettle rash and skin swelling
- Declared on label of Jamny Dubble Buble
- Yankee Dollar Store, Granville, N.Y.





# Cuttlefish Black

- Unapproved in U.S.
- Not known to cause illness or allergic reactions
- Declared on label of Strascinati 8 Sapori Pasta
- Provides a nice shellfish taste to pasta
