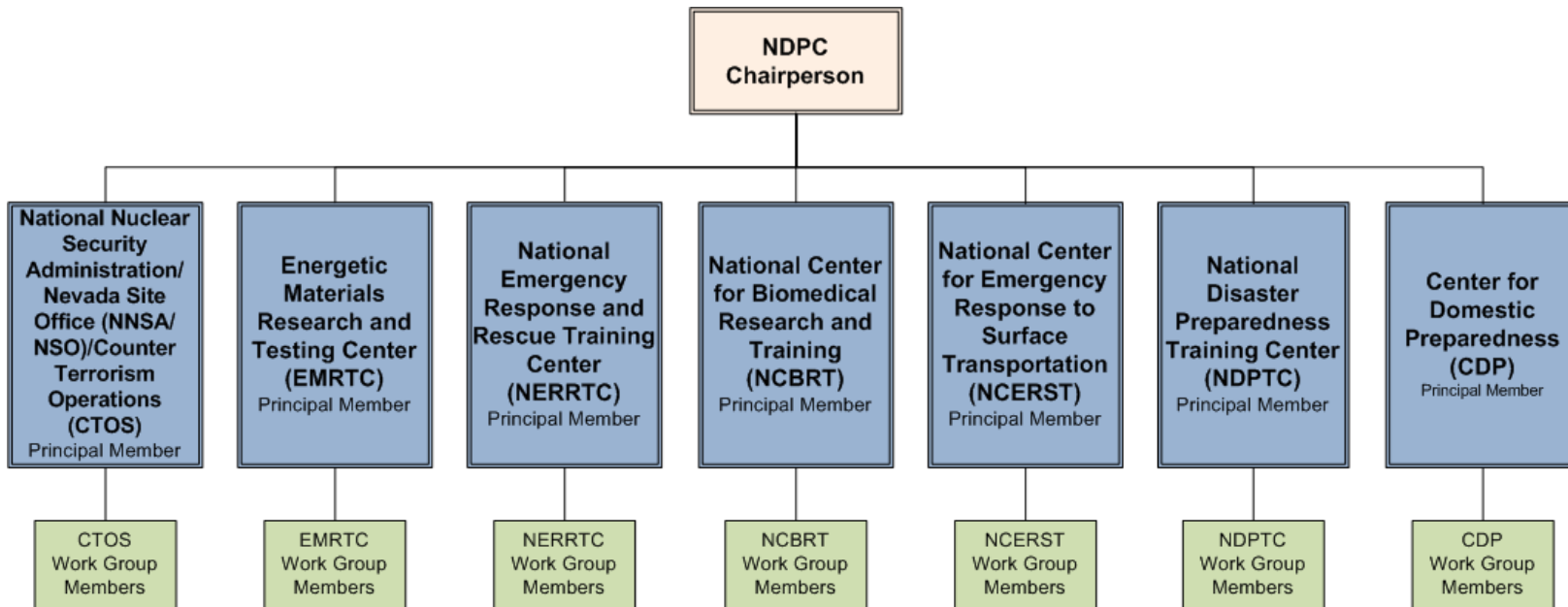

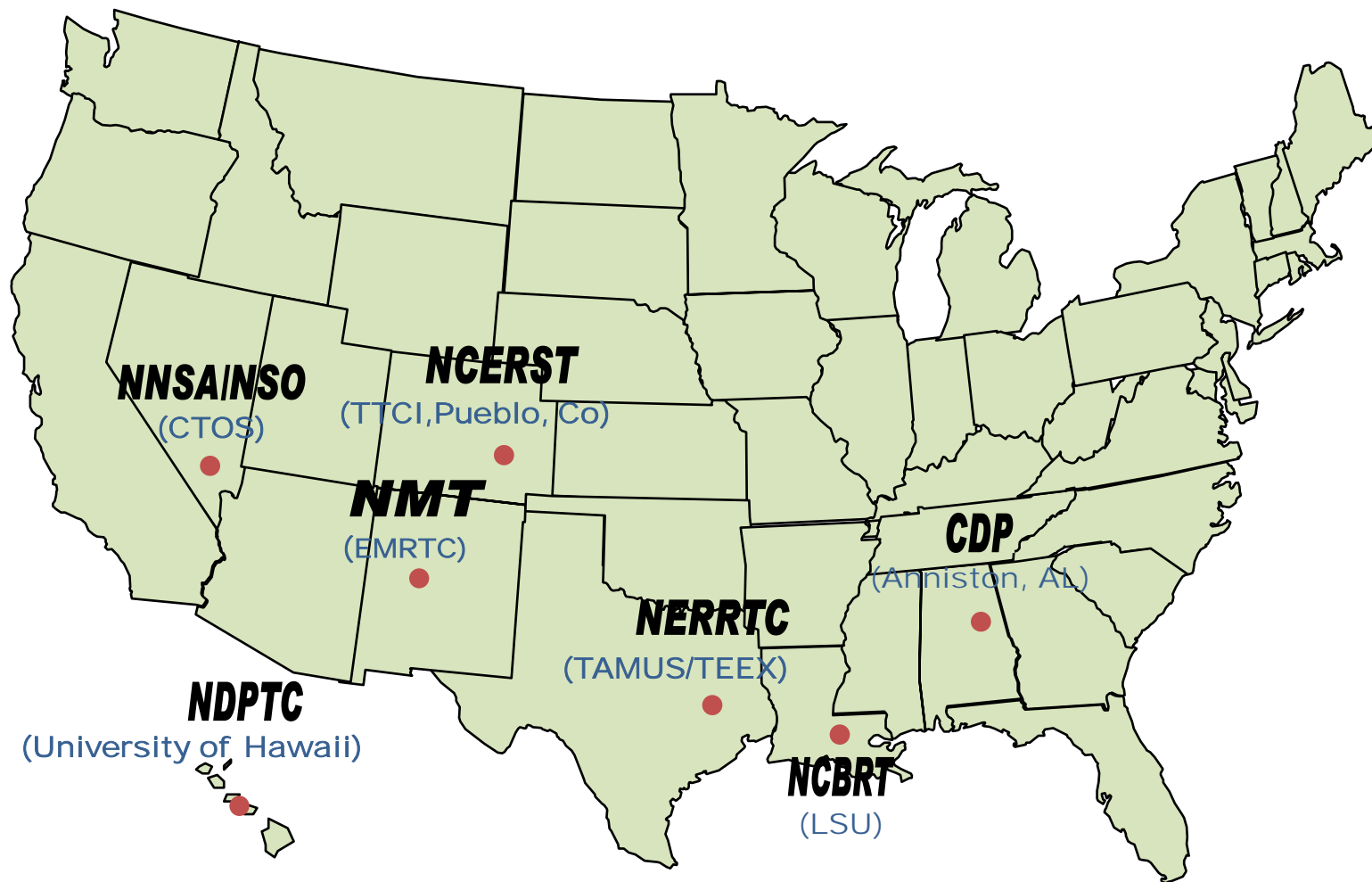

NDPC Lanes of Responsibilities

EMRTC	Explosive and incendiary attacks
NERRTC	Incident management, EMS, hazmat, public works, threat and risk assessment, senior executive programs
NCBRT	Prevention, deterrence and response to terrorist acts, law enforcement, biological, and food defense/agricultural related terrorism response
NNSA/NSO (CTOS)	Prevention, deterrence, and response to radiological/nuclear attacks
CDP	Prevention, deterrence, and response to CBRNE hazards and healthcare/public health mass causality events
NCERST	Prevention, protection, response, and recovery from incidents involving surface transportation
NDPTC	Monitoring natural hazards, evaluating risks to urban populations and planning for the response, recovery, and reconstruction of areas following a disaster.

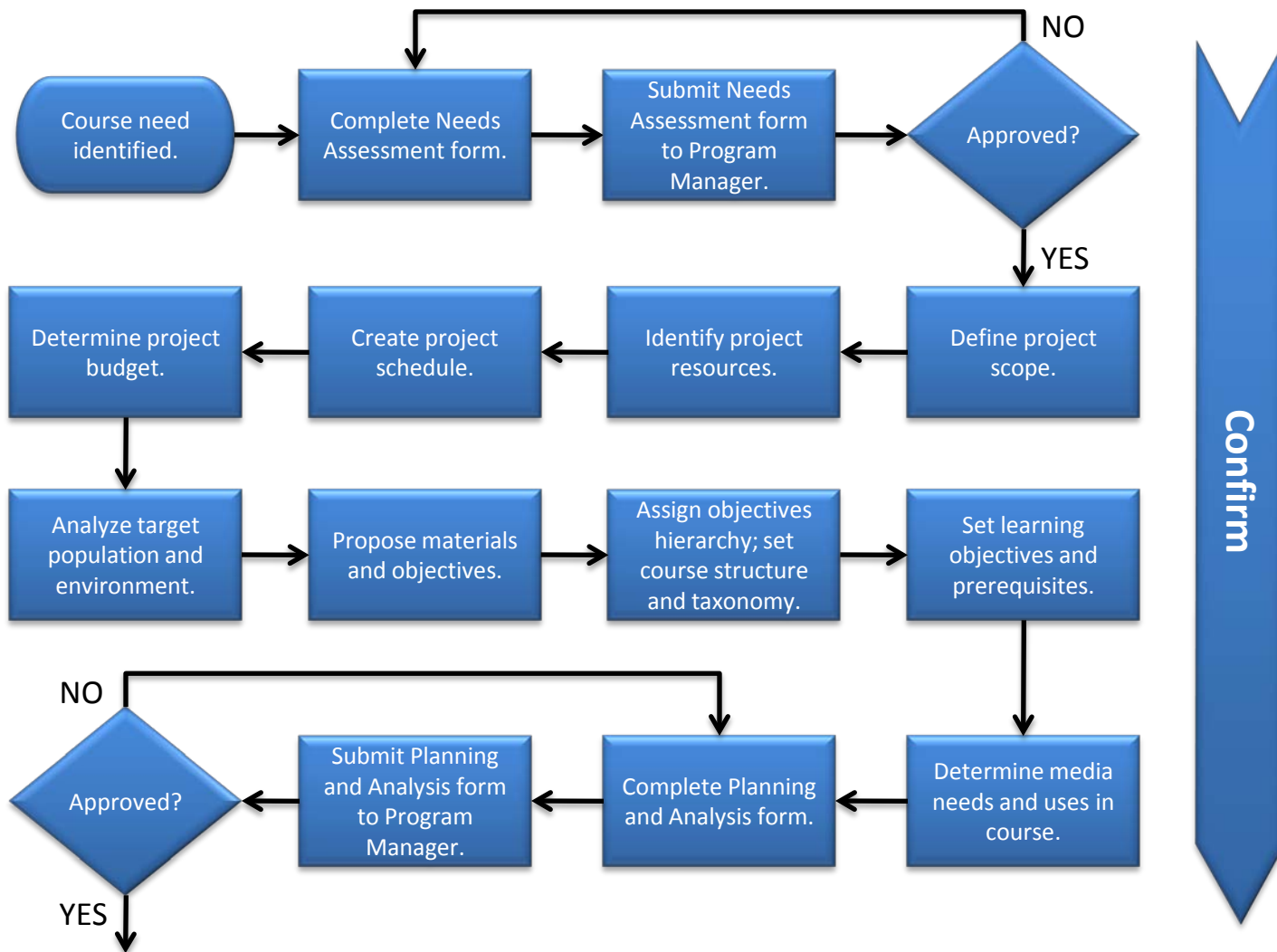

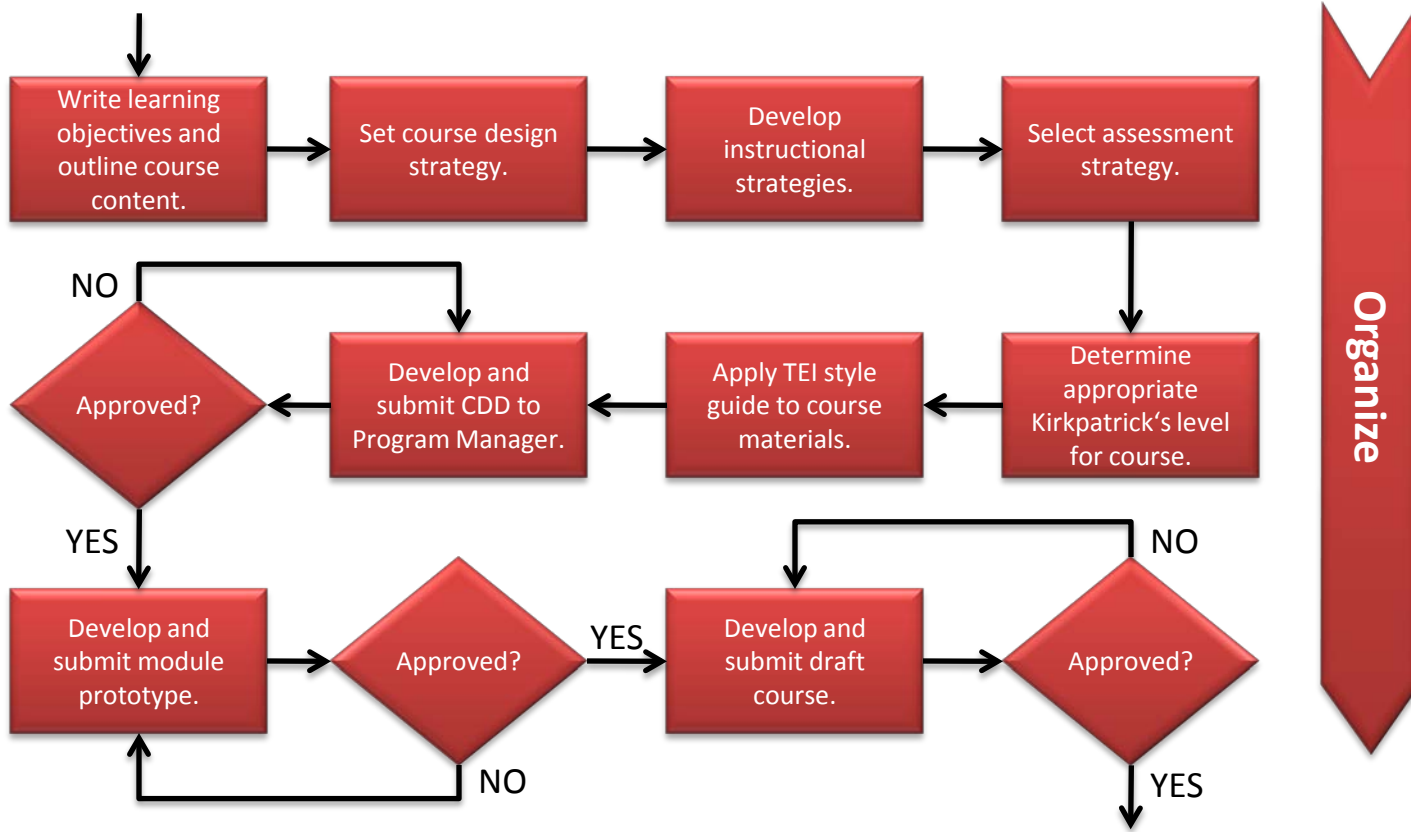
Curriculum Development Process

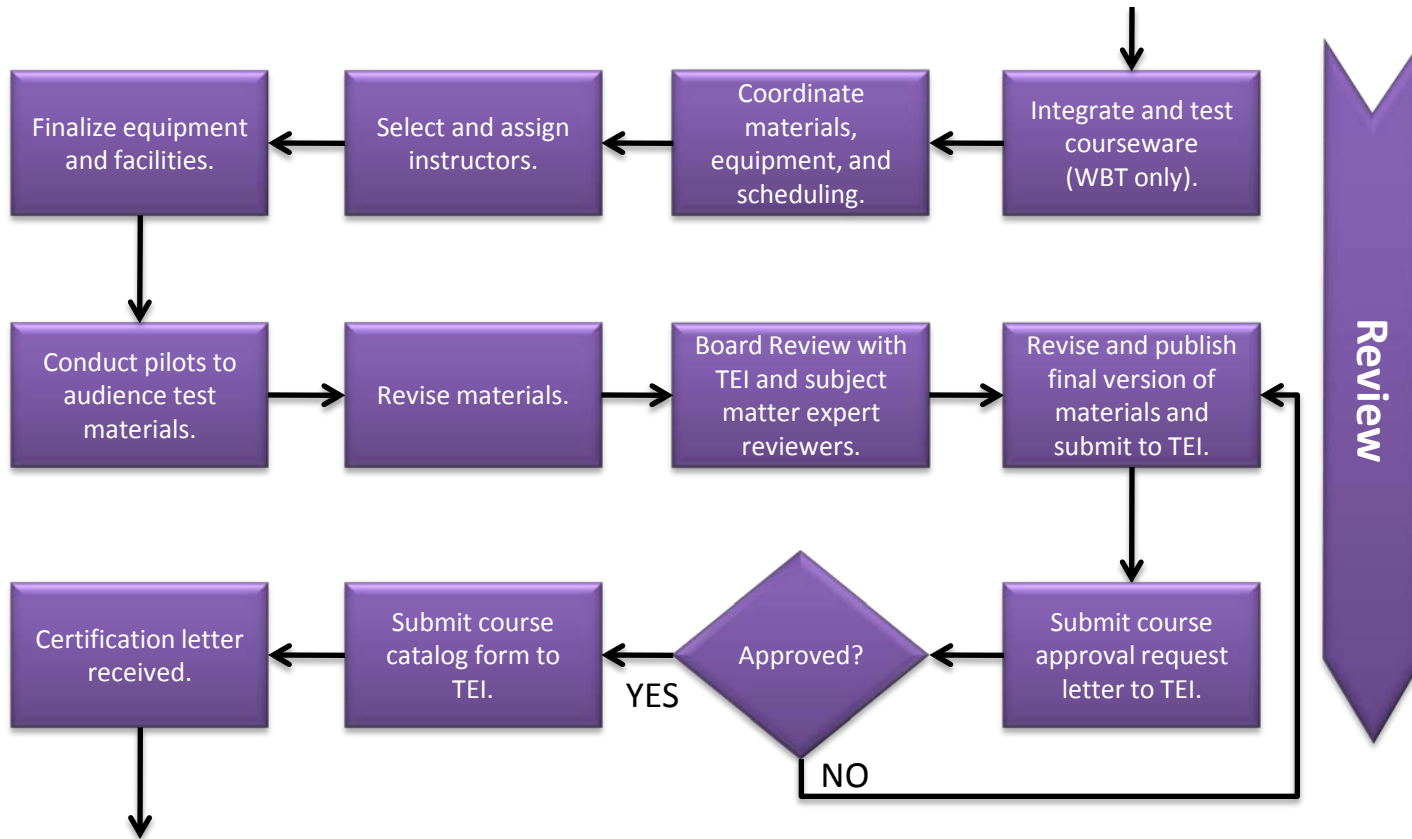

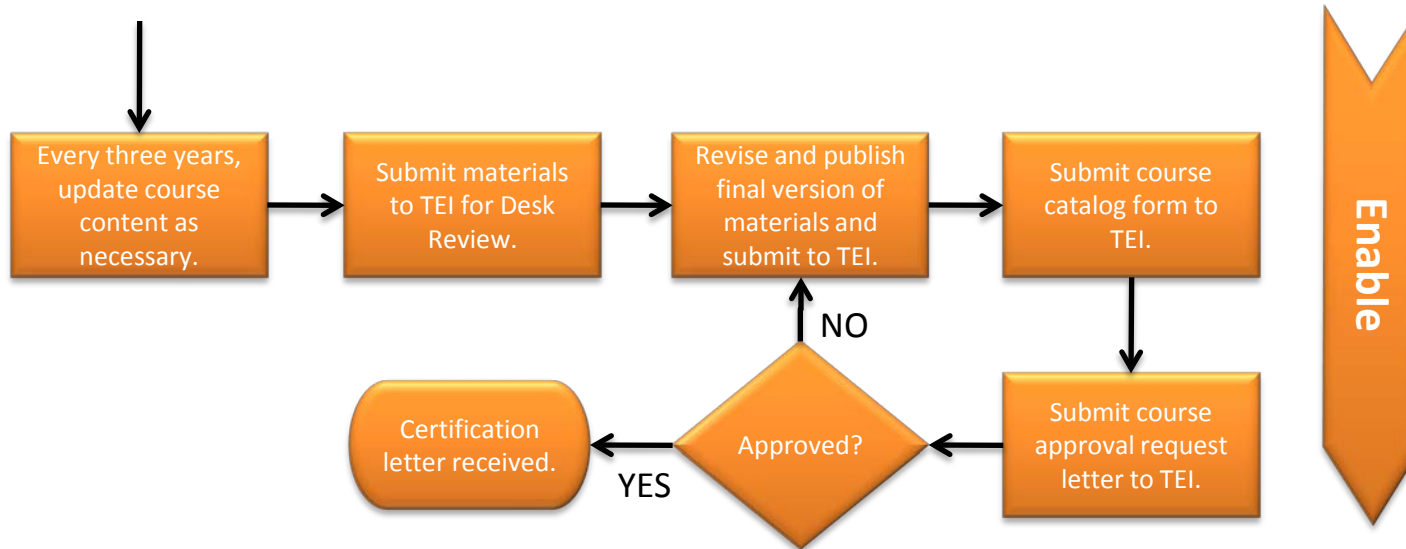

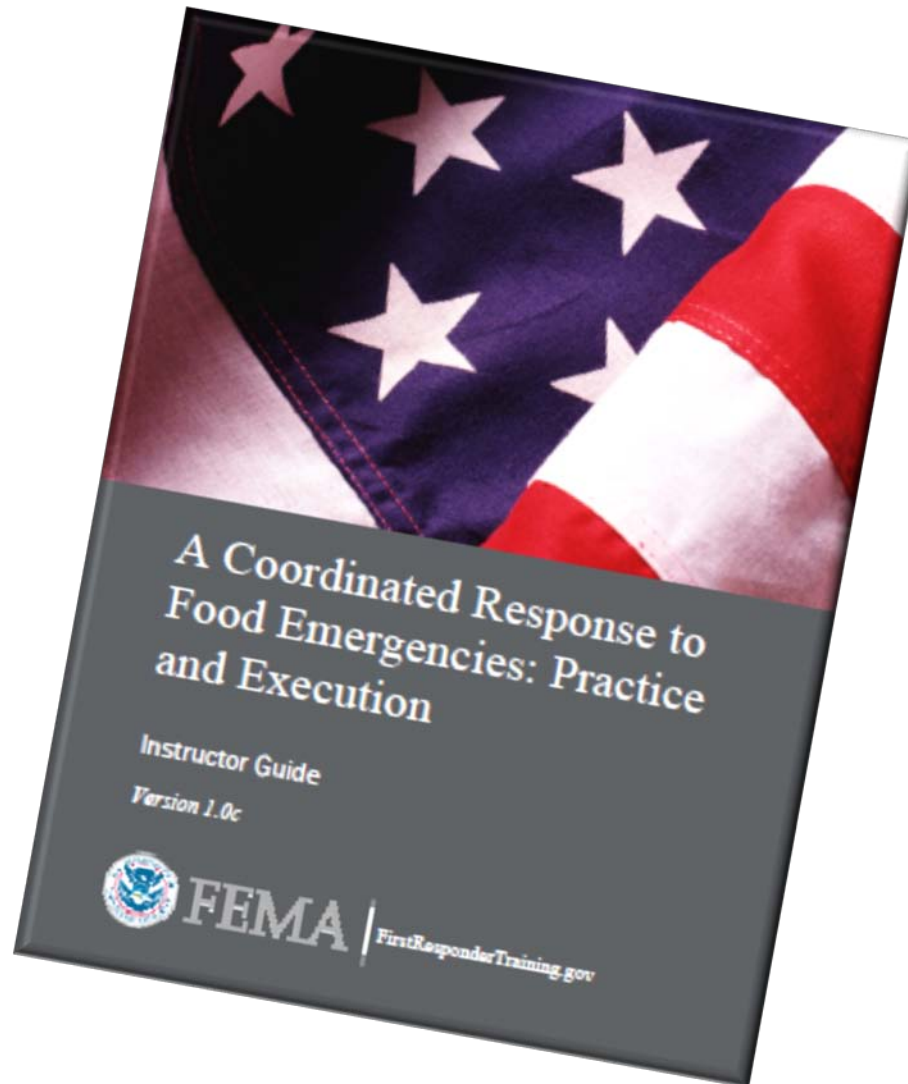
