KEN STEVENSON – VP OF REGULATORY AFFAIRS OF CEUTICAL LABS RECEIVES THE ASSOCIATION OF FOOD & DRUG OFFICIALS (AFDO) INDUSTRY ASSOCIATE MEMBER AWARD

Burlington, Vermont – Ken “KC” Stevenson, Ceutical Labs was awarded the AFDO Industry Associate Member Award at the 122nd AFDO Annual Educational Conference on June 12, 2018.

Qualification for this award is based upon long-term active membership in the Association, active involvement in committee work, development of model codes and demonstrated promotion of the objectives of the Association. This award is presented each year at the Annual Educational Conference.

Ken Stevenson has been with Ceutical Labs for over 13 years. He is VP of Regulatory Affairs and manages the electronic submission of regulated data and information to FDA from Ceutical Labs. Mr. Stevenson is the current Secretary of the Structured Product Labeling (SPL) Industry Working Group. He participated in the Regulated Clinical Research Information Management (RCRIM) – Study Data Standards Project to develop data standards for the submission of clinical and non-clinical research study protocols and study designs. Ken is a founding member of the BioNorthTX Regulatory Affairs and Quality Assurance (RA/QA) Committee.

KC was instrumental in the creation of AFDO’s Body-Art Committee. He currently serves as Chairman. His committee develops guidance documents for tattoo ink labeling and serves as a forum for industry representatives and regulatory official to discuss current issue and concerns in the body-art community. In 2017, Ken participated in a live tattoo demonstration during the AFDO Educational Conference. Courtland Imel, Ceutical Labs CEO said, “It is an honor and privilege to award the first human sacrifice for AFDO in over 100 years as this year’s recipient of the Associate Award. Mr. Stevenson was quite capable of receiving this mighty award after sacrificing his arm to the betterment of the AFDO Body Art Committee.”
