



Retail Program Standards Grant Program Reporting and Reimbursement Instructions

Interim Reports: Required for Category 2 projects only, due on the date specified within the grant portal.

Final Reports: Required for all project types (Categories 1, 2, 3, and 4), due 45 days after the end of your project period.

Reimbursement: Reimbursement for the full amount of your subaward will be made after the Final Report is completed and submitted including attachment of the Reimbursement Form and required documentation. For travel-related expenses, please use one line item for each travel expense. Reporting and Reimbursement Instructions:

Hint: Many grantees find it helpful to gather the required information into a single word processing document, and then cut and paste that information into the grant portal. This can prevent the loss of work-time caused by Internet connection issues.

1. Log into the grantee portal at <https://retailstandards.fluxx.io> using the login and password you received during the application process. If you cannot find your username and/or password, or if you have any questions, please visit https://retailstandards.fluxx.io/forgot_password. Alternatively, you may contact us at 1-850-583-4593 or retailstandards@afdo.org.
2. Through the grantee portal you have access to the following information:
 - a. The **Applications** section gives you access to *Draft, Revisions Needed, Submitted for Review, and Declined* grant applications.
 - b. The **Grants** section gives you access to all of your subawards under this grant program. Subawards are listed by their Grant Number (each is clickable), with summary information provided. By clicking on the Grant Number for your subaward(s), you can get detailed information including: *Grant Number* (at the top of the screen), *Project Title, Point of Contact Name, Name of Authorizing Official, Project Start and End Dates, Project/Training Summary, Project/Training Participants, and Project/Training Outcomes* and other project information. You can also retrieve a copy of your *Award Letter* (near the bottom of the detailed grant page for each subaward).
 - c. The **Payments** section gives you information on payments completed (in most cases to be made after submission and approval of your final report and supporting documents.)

- d. The **Reports** section lists all of your required reports, with *Due Date* and *Status* for each.
3. **Interim Report Instructions - For Category 2 Projects Only**
 - a. On or before your due date, scroll down to the **Reports** Section and click on the “Reports Due” link for your Interim Report. Once you have clicked on a report, basic grant information is displayed along with the incomplete Report Information questions. (If your report is past due, you must click on “Overdue Reports” to begin submission.)
 - b. Click the, “Edit” button toward the top of the page.
 - c. Accurately provide answers to all questions in the Report Information section, noting that some of the fields are restricted to 1500 characters. (You may click the “Save” button at the bottom of the page at any time to save your work.)
 - d. When finished, click the “Save” button. If any changes are needed, you may again click “Edit” at the top of the screen.
 - e. Click “Submit Report.” This will submit the report.
 - f. To verify your submission, click on “Submitted Reports” from the left menu, and select the report in question. The status of your report will show as “Received.”
 4. **Final Report Instructions - For All Project Categories (1, 2, 3 and 4)**
 - a. When your project is complete and you are ready to apply for reimbursement, scroll down to the **Reports** Section and click on the “Reports Due” link for your Final Report. Once you have clicked on a report, basic grant information is displayed along with the incomplete Report Information questions. (If your report is past due, you must click on “Overdue Reports” to begin submission.)
 - b. Click the, “Edit” button toward the top of the page.
 - c. Accurately provide answers to all questions in the Report Information section, noting that some of the fields are restricted to 1500 characters. (You may click the “Save” button at any time to save your work.)
 - d. In the “Report Documents” section, using the “+” sign, please upload the following documents:
 - i. The completed *Retail Program Standards Grant Program Reimbursement Form* listing your approved expenses. (Located at: http://afdo.org/Resources/Documents/vnrfrps/Reimbursement_Form.docx.)
 - ii. Scanned PDF copies of verifying documentation for all expenditures (verifying documents include receipts, invoices marked paid, payroll reports, mapped documentation of mileage, expenditure reports, etc.), preferably in the same order as listed on the Reimbursement Form.
 - iii. *If your project involved a Self-Assessment, Verification Audit(s), or achievement of a new standard, be sure you have sent the FDA Regional Retail Food Specialist assigned to your jurisdiction “Appendix I” or FDA forms SF3519 and SF3520 in addition to attaching them to your final report. If you have any questions regarding this requirement, please contact your FDA Regional Retail Food Specialist.*

- e. When finished, click the green “Save” button. If any changes are needed, you may again click “Edit” at the top of the screen.
- f. Click “Submit Report.” This will submit the report.
- g. To verify your submission, click on “Submitted Reports” from the left menu, and select the report in question. The status of your report will show as “Received.”
- h. Your grant manager will contact you if there are any questions about your report and reimbursement request, or if any information is missing. Before reimbursement is made, your grant manager will confirm with the FDA Regional Retail Food Specialist assigned to your jurisdiction that all required FDA forms related to your project have been turned in and are complete.
- i. Use your login and password to log back into your grantee portal as often as you would like to check on the status of your submitted reports. Most reports will be processed within 1 week. Under the “Reports” header, click on “Completed Reports,” to see if your report has been approved.
- j. Once your Final Report shows as “Approved” you can expect to receive payment in 2 - 4 weeks.
- k. Once a payment has been made, the amount, paid date, and check number of the payment will be reflected in the “Payments” section of the grantee portal.
