Food Safety Legislation Pending/Failed 2016

July 21, 2106

During the 2015-2016 legislative session, states proposed 168 bill relating to food safety that either failed or are still pending. In total, 34 states proposed legislation on the subject: AK (2), AZ (1), CA (15), CT (3), DC (1), FL (5), GA (1), HI (22), IA (9), IL (7), KS (1), LA (1), MA (), MD (2), ME (4), MN (5), MS (5), NC (3), ND (1), NE (1), NH (1), NJ (9), NY (24), OK (7), PA (2), RI (12), SC (1), UT (1), VA (1), VT (3), WA (2), WI (6), WY (4), WV (3).

The popular legislative topics included milk and dairy (32), animal feed and animal antimicrobials (3), cottage foods market (27), food facilities (37), marketing (25) and general food safety (25).

Milk and Dairy

During the 2015-2016 legislative session 17 states proposed 32 bills relating to milk and dairy that failed or are still pending.
