FDA and AFDO Partner to Award Year 5 Grants to State, Local, Territorial, and Tribal Regulatory Retail Food Programs

The U.S. Food and Drug Administration (FDA) and the Association of Food and Drug Officials (AFDO) are proud to announce Year 5 of the AFDO administered Retail Program Standards Grant Program. Opening on Monday, September 4, 2017 and accepting applications through Monday, October 2, 2017, the program provides funds for the completion of projects and training to enhance conformance with the Voluntary National Retail Food Regulatory Program Standards (Retail Program Standards). Grant funding is open to State, local, territorial, and tribal regulatory retail food programs that have enrolled in the <u>Retail Program Standards</u>. Applicants to this program can expect a simple application process, up-front funding when required by the project, and simple reporting requirements.

Funds are available for completing projects that meet Retail Program Standard goals and objectives in four categories:

- **Category 1:** Small Projects (up to \$3,000) Examples: Completion of Self-Assessments of all 9 Standards, Verification Audits, Small Projects that help advance or maintain conformance with one or more Standards
- **Category 2:** Moderate Projects (\$10,000 to \$20,000) Examples: Completion of Foodborne Illness Risk Factor Studies, Implementation of Comprehensive Intervention Strategies to Reduce Risk Factors, Moderate Projects that help advance or maintain conformance with one or more Standards
- **Category 3:** Training (up to \$3,000) Examples: Travel to training courses, workshops, and seminars that advance the goals of the Retail Program Standards
- **Category 4:** Food Protection Task Force Projects (up to \$3,000) The goal of this category is to advance conformance with the Retail Program Standards by supporting attendance at Food Protection Task Force Activities (or similar Food Advisory Board/Council activities, whether or not the Task Force/Board/Council is supported by an FDA grant).

Jurisdictions that applied and/or were awarded funds in Year 1-4 <u>are</u> eligible to apply again for funds in Year 5. Jurisdictions can apply for funding for one project in each of the four categories for a maximum of four applications per jurisdiction. Total funding for this program for Year 5 is estimated to be \$1,421,250. This will enable a significant number of awards for jurisdictions in all four project categories.
