




FDA Rapid Response Team Program

Notification of Outbreaks

- Health Department- Epi/EH reporting
 - Collecting illness reports
 - Specimens may be taken and submitted to a clinical lab confirming illness
 - Tie into CDC and isolate reporting

- State or local health
- State manufactured food program
- Rapid Response Team
- FDA State Liaison or Emergency Response Coordinator





Outbreak Investigation

- FDA may have an assignment for traceback
- State manufactured food program may start investigation and tag in Produce Team
- Rapid Response Team and or Epi may be investigating as well
- FDA hosts CORE Calls
- Know your partners!







How you may be involved...

- You may be asked to assist with traceback investigation
- Notify PSN of foodborne outbreak involving produce
- Conduct a visit
- Coordinate with FDA with farm level traceback



What Georgia Does...

- Include Produce Safety Team on weekly RRT check-in calls
 - Communication with Fed partners, EH, Epi, Manufactured Food, Retail, Lab- great relationship building!
- Include Produce Safety Team in RRT trainings, exercises; familiarity before an incident
- Include Produce Safety PM on CORE Calls, if necessary





Georgia Cucumber Case Study

- July 2024- Holiday weekend, of course?!
- GA RRT notified by Michigan RRT of positive STEC and 3 Listeria samples at retail of whole cucumber (multiple positives from different locations)
- Immediately started traceback with Produce Safety Program Team
- 3 Listeria positives all tied back to Georgia farm

• STEC was "labeled" GA but then tied back to Mexico after extensive traceback with retailer. Retailer was reusing boxes in back of store for organizing produce

for shelves





Georgia Cucumber Case Study

- 4 more Listeria positives found from another Michigan retailer- while they were originally from GA, these were tied to an OH firm that also had positives (enviro swabs taken)
- Cucumbers moved from Georgia farm to average of 3 other firms by the time it hit the retail shelves
- Importance of traceability ©
- Produce team conducted visits at GA farms. All farms were done with cucumbers by the time traceback was concluded.
- Props to MDARD for this exemplary work on their sampling blitz!
